

# **Regulations Governing the Dong Ya Driving School Founder Chang Chin-po Scholarship for Economically Disadvantaged Students at National Yang Ming Chiao Tung University**

Formulated at the 3rd administrative directors meeting of the College of Management for academic year 2021 on Nov 1, 2021

- Article 1 Mr. Chang Chin-po, founder of Dong Ya Driving School, was a technician specialist at the Hsinchu City Construction Bureau, an electric car instructor at the Taiwan Railways Administration, a technical specialist at a police department, and worked at the Inspection and Testing Section in the Motor Vehicles Office under the Ministry of Transportation and Communications. In 1949, he founded Dong Ya Driving School and Ya Dong Driving School, both of which are dedicated to safe driving education. A successful businessman, he was also a philanthropist. To fulfill his wishes and to encourage students in the College of Management at National Yang Ming Chiao Tung University (hereinafter the University or NYCU) who are economically disadvantaged or have experienced sudden financial difficulties to pursue their studies and give back to the community after graduation, the family donates a sum of NT\$300,000 per academic year to the College of Management to set up the "Dong Ya Driving School Founder Chang Chin-po Scholarship for Economically Disadvantaged Students at National Yang Ming Chiao Tung University."
- Article 2 Award Recipients: Ten places for graduate and doctoral students in the College of Management, including five in the Dept of Transportation & Logistics Management and five in departments of the College of Management other than the Dept of Transportation & Logistics Management.
- Article 3 Eligibility:
1. Students who are citizens of Taiwan and are enrolled in any programs of the NYCU College of Management.
  2. Exceptional circumstances (e.g. low-income households, middle-low-income households, economically disadvantaged, sudden family emergencies or other special reasons).
  3. Not receiving any other scholarships.
  4. Recommended by a tutor/advisor or department/institute head.
- Article 4 Documents Required for Application:
- Applicants should complete an application form together with a photocopy of the following documentation:
1. A copy of letter of recommendation from a teacher, and a certificate of outstanding performance or representative deeds.
  2. A photocopy of household registration certificate as well as a statement of sudden financial hardship and supporting documents (e.g., proof of income tax return for the whole household, proof of low-income households or middle-low-income

households, proof of income tax exemption or a statement of sudden hardship in the family).

3. Letters of recommendation from a tutor/advisor and department/institute head required for those from middle-low-income households.

Article 5 Scholarship Scheme: Ten places per academic year at NT\$30,000 each, with a total scholarship amount of NT\$300,000. Applicants are limited to two awards during the course of their studies.

Article 6 Application Period: Applications should be made to the departmental offices within one month of new school year registration in the first semester of each academic year.

Article 7 A Dept of Transportation & Logistics Management affairs meeting is authorized to review the allocated places and send them to the College's administrative directors meeting for reference while the remaining places are examined by an administrative directors meeting of the College of Management.

Article 8 Any unused scholarship places will be reserved for the second semester.

Article 9 These Regulations shall come into operation upon approval by an administrative directors meeting of the College of Management, and the same applies to any subsequent amendments hereto.
